NOTIFICATION

Whereas, constitution of a separate Technical Expert Committee at Maldah catering to the districts of Maldah, Uttar Dinajpur and Dakshin Dinajpur towards issuance of Fire Safety Recommendation (FSR), Revised Fire Safety Recommendation (RFSR), Fire Safety Certificate (FSC) and Renewal of Fire Safety Certificate (RFSC) was under active consideration of the Government for some time past in order to promote the ease of doing business as well as compliance to the provisions of West Bengal Fire Service Act & Rules framed thereunder;

Therefore, in partial modification of the G.O. No. 233/FES/O/MISC-06/2022 dated 18.05.2023 read with G.O. No. 982/FES/O/MISC-06/2022 dated 08.09.2022 issued by this Department, the Governor is hereby, pleased to constitute the Technical Expert Committee, Maldah for the districts of Maldah, Uttar Dinajpur and Dakshin Dinajpur with the following composition:-

This newly constituted Technical Expert Committee, Maldah shall function as a separate entity from the Technical Expert Committee, Siliguri, North Bengal to recommend its decision to the Director General, West Bengal Fire Services towards issuance of FSR, RFSR, FSC and RFSC;

The Technical Expert Committee, Maldah shall meet at least twice in a month.

All other parameters elucidated in the G.O. No. 233/FES/O/MISC-06/2022 dated 18.05.2023 read with G.O. No. 982/FES/O/MISC-06/2022 dated 08.09.2022 shall remain same and be complied with by all the concerned in letter and spirit.

This notification is issued in the public interest and with immediate effect.
